1st Witness GIACONI GENEROSO Italy born:-

I am 48. At 44 in village at MOLINA DI QUASTA.
I always lived in PISA and had gone to other villages
during a period of emergency. This community bombed
till the citizens took shelter. 7 August 44 early morning
0300 hrs Germans carried out bombing at Pisa in locations
near MOLINA DI QUASTA. Before this had ever been
Germans near M.D.Q. but on this morning Germans came
near by and into M.D.Q. On 7th August same
came to me, my wife & daughter to a place
South of M.D.Q. We ran wounded up in MOLINA
which is about 600 meters above M.D.Q. We were separated
- man & woman - and a bullet hit one to
indirectly. A young boy during German
period he they had very difficult for living
in that area & were very poor. It was true.
This girl was sent with us & the other women
was taken away. They stopped her ~~to~~ ^{to}
The woman was ① NOZZO. The men were

From No. RIPAPRATTA. Then the ~~all~~ bodied men
were sent to LUCCA. Part were sent to Siena & part
No N Italy to work. The unfit & the young body were
taken to School in NOZZANO. Some one of the
unfit went to NOZZANO. There were 65 at first but
increased to 71. We were 5 days here from Aug 9
11 August: We were treated like animals. He didn't
have a day, we had to clean once a day. We were given
about 10g of bread - 1 or 2 hours duty. On 5th they
the 48 came & told us we had to go to hospital
for medical examination. I was exempt first &
the 4 had to go in vehicle. We were taken to
Dress and then MASSAROSA. New Name was in
list & we were ordered to dismount. It took us
up & down paths at us. Driver pushed us ~~up~~
into woods and to edge of cliff & we had now
no fall in to one straight line. The Guard
not fall in told the ^{Road 10} Guard ~~to~~ at me with his
mfg. The bigger jumped. I don't even ~~cliff~~ ^{up}
believed to be dead as the driver had ^{up} found
no pulse at me. I got up and went through
bushes & came to hole back & then heard
the RT fire. I wonder would for the day &
came to AVAGNA in province of PISA.
I was captured three days later. Remained
of ~~sick~~ men & women dead. All killed some
a day. I know belonged to SS ^{main at school} ~~at school~~

from set up this to partisan & was with big
partisan. Partisan ~~PARASCA~~ was about 500 meters from NOVARA.
Then we a strip of sheltered area. On the occasion of the
airing out' action there was no exchange of shms
between Partisan & Germans. On the August
I was at a farm house with my family. At 0700 hrs
we were still in bed. I was sick. First German looked at
Me and said "I told me No stay in bed & took away
the bed of my family. When I was taken away
— about 1 hr late. When second Nazi came
who was with me was sent away to another hut
I knew the soldier came from Part in NOVARA
because I saw him being there. I do not know
the unit. Over 100 the total we were sent away.
All 71 like to shoot belonged to my village.
I was only in there 10 days. I knew them by signs
that we have. I saw them at NOVARA but had seen
the before. I do not know if soldiers led him to
NOVARA. They I know they were SS because
they had longer hair. The 11th the last to shoot
he was small in height but pretty fat and strong.
^{I was} strong enough to attack him.
He was young. He did my get with me a day
for few days we were in house with windows &
doors closed. We were taken away in ~~the~~ ^{to} ~~in~~ ^{of}

in Mikoyan. After 2 day that morning I had news
+ people here who push in his find at. 1000
of many 70 killed 4 by 4 - lost in shell hole.
I know the 70 was R.D. because I heard it at home
on 15th May 40. The shooting 102 gun is 44. I did

The same machine appeared on the second time

I spoke to the families of the 70 killed.
then I can talk for Savary. ~~you found~~
by Dr. ^{on the 15th of May 40 of which I was a witness} I know many killed were
families from them then.

I said so three days before of persons who
had been in shell with me. They had relatives
saying "the bullet found at Savary 1000m in
the back". I saw those bodies on an Anti-shade
near AVIGNA. The fourth man is witness here.
