1st Witness

GIACONI ENEEROSO duly sworn -

I am 47. My 44 in village at MOLINA DI QUORA. I always lived in PISA and led you to other village during a period of emergency. Price continuously hiked till the citizen took shelter. 7 August 44 early morning 0300hrs Germans arrived at village up operation in location near MOLINA DI QUORA. Before this had never seen Germans near M.D.Q. but on the morning Germans came near M.D.Q. On 7th August Germans came & took me, my wife & daughter to a place South of M.D.Q. We were rounded up in MOLARATA which is about 600 meters from M.D.Q. We were separated - men to work - and a lieutenant asked some 10

indicate positions. A young lady staying here told him they had only shelter from bombing in that area & were very fortunate. It was true. This girl was sent with us to the Swiss women who taken away. They stayed there.

The 11th was seen ① NOZZO. The men were

When No. RIPASCRATTA. Then the other bodied men  
were sent to CUCCA. Post was sent to Senigallia & post  
No. N. Italy No work. The unfit of the young boys were  
taken to school in NOZZANO. I was one of the  
unfit sent to NOZZANO. Then were 65 at first then  
increased to 91. We were 5 days there from evening of  
11 August. We were treated like animals. We drank  
one a day, and to exercise one a day. We were given  
almost nothing to eat - 1 or 2 loaves daily. On 5th day  
the Lt came & said we were to go to hospital  
for medical examination. I was amongst first 4.  
The Lt had to get in vehicle. He was taken to  
Ancona and then MASSAROSA. Mussolini was in  
exile & we were ordered to dismount. It rained  
and drove back at us. Driver took us through  
into woods and to edge of cliff & we then saw  
No fall in to one straight line. Then I did  
not fall in but the Lt <sup>knelt</sup> ~~knelt~~ at me with his  
only. The trigger jammed. I had one <sup>cliff</sup> ~~cliff~~  
pretended to be dead as the driver had <sup>cliff</sup> ~~cliff~~  
also shot at me. I got up and ran through  
brush & came to hole back & then heard  
the Lt fire. I wandered round for two days &  
came to AVARNA in province of PISA.  
I was captured then 3 days later. Reminded  
of <sup>sick</sup> ~~sick~~ men & women dead. All killed same  
day. I know <sup>stream at school</sup> ~~stream at school~~ No 58 ~~school~~

<sup>XXD</sup>  
~~XXD~~ Green sent supplies to Partisan + was w/ in league  
with Partisan. CASASUA was about 500 meters from NOZANA.

She was a staff of skilled work. On the occasion of the  
conducting out action there was no exchange of shells  
between Partisan + Seniors. On 7th August

I was at a farm house with my family. At 0300 hrs  
we were still in bed. I was sick. First Seniors looked at  
them and told me No stay in bed + look away  
the rest of my family. Later I was taken away

— about 1/2 hr later. Home sent + Miss Seniors  
who was with us were sent away to their tent

I knew the soldiers came from Part in NOZZANO  
because I saw them long time. I do not know  
their name. Over 100 other soldiers were sent away.

All 71 taken to school belonged to my village.  
I was only in there 10 days. I knew them by sight

but not name. I saw them at NOZZANO but had seen  
them before. I do not know if soldiers led her to  
NOZZANO before. I know they were SS because

they had badges SS. The 1st who tried to shoot  
me was small in weight but pretty fat and strong.

I was strong enough to attack him.  
He was young. He did not get well one a day.  
For few days we were in town with windows +  
doors closed. We were taken away in ~~the~~ ~~time~~ of

Wicks wagon. After 2 days I had recovered. I had a piece  
of paper done with bush in two feet at. Under 150  
of money 70 killed 4 by 4 - lost in shell hole.  
I know the 70 was shot because I heard it at home  
on 15th May 45. The shooting took place in 44. I did  
not know until a year later. I know 15 personally.  
The same soldiers captured on the second time  
as the first. They only sent me home.

Rec'd I spoke to the families of the 70 killed.  
when I came back from January. I was found  
by Dr I know <sup>of the body of one of which I was a member</sup> ~~some~~ there & were killed because  
families found them there.

I did see three dead bodies of persons who  
had been with me. They had been  
saying "then Marshall found at Simon's station in  
the back" I saw these bodies on an Autostrada  
near AVARNA. The father was in witness here.
